**Item 2.02 Results of Operations and Financial Condition**

On May 1, 2008, the Company issued a press release reporting the financial results of the Company for the fourth quarter of fiscal year 2008 ended March 29, 2008. On January 28, 2008, the Cirrus Logic Board of Directors authorized a share repurchase program of up to \$150 million. The repurchases will be funded from existing cash and will be effected from time to time in accordance with applicable securities laws through the open market or in private transactions, depending on general market and economic conditions. On April 28, 2008, the Company completed their authorized stock repurchase program for a total of \$149,999,997 with 24,543,917 shares repurchased and constructively retired.
