- (1) The shares acquired represent the vesting and automatic settlement of 2894 of the Reporting Person's restricted stock units on March 1, 2017
  - (2) Represents shares withheld in connection with the payment of withholding taxes due upon vesting and settlement of restricted stock units.
  - (3) The shares acquired represent the vesting and automatic settlement of 2891 of the Reporting Person's restricted stock units on March 1, 2017.
  - (4) The shares acquired represent the vesting and automatic settlement of 1140 of the Reporting Person's performance restricted stock units on March 1, 2017.
  - (5) The shares acquired represent the vesting and automatic settlement of 1443 of the Reporting Person's performance restricted stock units on March 1, 2017.

The restricted stock units are settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.
  - (7) On February 27, 2015, the Reporting Person was granted 34695 restricted stock units, vesting in a series of twelve successive equal quarterly installments beginning on March 1, 2015, so that the restricted stock units will become fully vested on March 1, 2018. The restricted stock units are settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.
  - (8) Following determination of achievement of 2014 performance goals, the Reporting Person received 13683 performance restricted stock units, vesting with respect to 1/3 of such units on March 1, 2015, and with respect to the balance in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 1, 2017
  - (9) Following determination of achievement of 2015 performance goals, the Reporting Person received 17320 performance restricted stock units, vesting with respect to 1/3 of such units on March 3, 2016, and with respect to the balance in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 3, 2018
