In addition, customers will continue to earn their individual AAdvantage miles and companies will be able to continue managing all aspects of its Business ExtrAA account via the website.

**How will merging with US Airways impact the AAirpass program?**

The AAirpass program including unrestricted, fixed-rate air travel to both domestic and international markets, will remain unchanged and all VIP privileges, including complimentary Admirals Club membership, PriorityAAccess privileges, companion travel benefits and AAdvantage mileage accrual will remain intact.
