**1. What is the status of the equity grants made in 2003? Will they have any value after they expire in April 2013?**

The April 2003 equity grants were options granted to all of American's people at \$5 per share. These options cannot currently be exercised because the stock is not trading above that amount. Any of these options that have not already been exercised will expire by their own terms on April 17, 2013. Once they expire, they will not be reinstated and will not transfer to new stock for the combined company.

**2. How will US Airways' current policies on non-rev first class travel be incorporated into our new travel program once we merge?**

As we work through the merger integration process, we will have opportunities to thoroughly compare both companies' travel policies and will seek feedback as we develop the new program. For now, our non-rev program remains unchanged, including reduced 5-year and 25-year service charges.
