**LTE/4G DIGITAL CELLULAR MOBILE SERVICE (LTE FDD) OPERATION PERMIT**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcement issued by China Telecom Corporation Limited (the "Company") on 4 December 2013 in relation to China Telecom being granted the permit to operate the LTE/4G digital cellular mobile service (TD-LTE). The Board (the "Board") of directors of the Company announced that the Company was notified by China Telecommunications Corporation (the parent company of the Company) that China Telecom has been granted by the Ministry of Industry and Information Technology of the PRC the permit to operate the LTE/4G digital cellular mobile service (LTE FDD).

The Company will leverage the competitive edge of hybrid network and flexibly deploy the LTE network, leveraging collaborated use of different spectrum resources to meet customers' demand. Through its collaborated and integrated operation with the existing superior 3G network, the Company would grasp the rapidly growing data business opportunities with an aim to better enhance customers' experience and corporate return.

The Company believes that the issue of 4G digital cellular mobile service (LTE FDD) operation permit will be beneficial to the sustainable development of the telecommunications industry and the business of the Company as a whole. It will also foster the informatisation consumption and economic growth. However, it will simultaneously intensify market competition. The Company will proactively leverage its edge in full services operation and strive to foster the sustainable development of its business.
