Notably, our combined company will have a leading position in professional lines globally, as well as one of the largest excess and surplus lines and specialty product portfolios in the industry.

Until the transaction is complete, ACE and Chubb will continue to operate independently. For all intents and purposes, it will be business as usual. Following the completion of the transaction, which we expect will be in the first quarter of 2016, our combined organization will transition over time to operate under the Chubb name globally an acknowledgment of the distinctiveness and strength of its brand. Throughout the closing period, integration and beyond, you can rest assured that you will experience the same drive, discipline, superior service and commitment to our broker and agent partners that you ve come to expect from ACE.
