As of December 31, 2015, Mr. Levie held 50,000 shares of Class A Common Stock, 2,565,372 shares of Class B Common Stock and 2,024,464 shares subject to options to purchase Class B Common Stock that were fully exercisable within 60 days of December 31, 2015.

Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date. Each share of Class B Common Stock is entitled to ten votes per share, whereas each share of Class A Common Stock is entitled to one vote per share. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except with respect to the aforementioned conversion rights and voting rights.

The ownership percentage above is calculated based on 41,987,532 shares of Class A Common Stock outstanding as of December 31, 2015, as reported by the issuer to the reporting person, plus the assumed conversion of 4,589,836 shares of Class B Common Stock deemed beneficially owned by Mr. Levie, as described herein, into shares of Class A Common Stock.
