#### Item 5.07 Submission of Matters to a Vote of Security Holders.

The following proposals were submitted to the stockholders at the 2016 Annual Meeting of Stockholders (the Annual Meeting ) of Chiasma, Inc. (the Company ) held on June 9, 2016:

- (i) The election of three Class I directors, as nominated by the Board of Directors, to hold office until the 2019 Annual Meeting of Stockholders or until their successors are duly elected and qualified; and
- (ii) The ratification of the appointment of Deloitte & Touche LLP as the independent registered public accounting firm of the Company for its fiscal year ending December 31, 2016.

The proposals are described in detail in the Company s Proxy Statement filed with the Securities and Exchange Commission on April 25, 2016.

The number of shares of common stock entitled to vote at the Annual Meeting was 24,293,524. The number of shares of common stock present or represented by valid proxy at the Annual Meeting was 19,479,121. All matters submitted to a vote of the Company s stockholders at the Annual Meeting were approved and all director nominees were elected.

The number of votes cast for and against and the number of abstentions and broker non-votes with respect to each matter voted upon are set forth below:

#### (a) Election of Class I Directors.

There were 2,570,005 broker non-votes regarding the election of directors.

(b) Ratification of the appointment of Deloitte & Touche LLP as the Company s independent registered public accounting firm for the fiscal year ending December 31, 2016.

Stockholders ratified the appointment of Deloitte & Touche LLP as the Company s independent registered public accounting firm for the fiscal year ending December 31, 2016. The results of the voting included 19,337,709 votes for, 122,241 votes against and 19,171 votes abstained. There were no broker non-votes regarding this proposal.
