### GOL Announces Traffic Statistics for March 2006

**São Paulo, April 5, 2006** GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low fare, low cost airline, today released preliminary passenger statistics for the month of March 2006. System-wide passenger traffic (RPK) increased 50%, while capacity (ASK) increased 57% y-o-y. GOL's system load factor for the month of March 2006 was 69%.

Domestic passenger traffic (RPK) for March increased 45%, and capacity (ASK) increased 52%. GOL's domestic load factor for the month of March 2006 was 69%.

International passenger traffic (RPK) for March increased 122%, while capacity (ASK) increased 147%. International load factor for the month of March 2006 was 69%.

Yield per passenger kilometer was stable vs. March 2005, while average stage length (passenger trip) increased 23%.

- (3) *Load factor* represents the percentage of aircraft seating capacity that is actually utilized (calculated by dividing revenue passenger kilometers by available seat kilometers).
