### **GOL Foreign Currency Rating Upgraded to BB+ by Fitch**

**São Paulo, August 30, 2006** GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazilian low-cost, low-fare airline, announces that Fitch Ratings has upgraded the company's credit rating. The foreign currency IDR (Issuer Default Rating) has been upgraded from BB with stable outlook to BB+ with stable outlook. The rating of GOL's 8.75% perpetual bond issue was upgraded from BB to BB+. GOL's national scale rating is AA- (bra) with stable outlook.

The rating upgrade reflects the solid credit of the Company, that is the result of a business model based on low costs and high operational efficiency, says Richard Lark, CFO of GOL Linhas Aéreas Inteligentes.
