Description of Terms

Linked to the Invesco DB Commodity Index Tracking Fund

Unlike ordinary debt securities, the securities do not pay interest or repay a fixed amount of principal at maturity. Instead, the securities provide for a maturity payment amount that may be greater than, equal to or less than the original offering price of the securities, depending on the performance of the Fund from its starting price to its ending price. The maturity payment amount will reflect the following terms:

If the value of the Fund increases:

You will receive the original offering price plus 150% participation in the upside performance of the Fund, subject to a maximum return at maturity of 34% of the original offering price. As a result of the maximum return, the maximum maturity payment amount will be \$1,340.00.

If the value of the Fund decreases but the decrease is not more than 15%:

You will be repaid the original offering price

If the value of the Fund decreases by more than 15%:

You will receive less than the original offering price and have 1-to-1 downside exposure to the decrease in the value of the Fund in excess of 15%

Investors may lose up to 85% of the original offering price
