- (1) common stock from the 2008 GRAT. On the same date, the remaining 1,879,614 shares held by the 2008 GRAT were distributed to James J. Kim and the 2008 GRAT was terminated. Upon receipt of the 6,189,831 shares of Issuer common stock, the reporting person then contributed all 6,189,831 shares to Sujoda Investments, LP ("SI, LP"), a family limited partnership established for the benefit of members of the James J.
