The restricted stock units were granted under the Santander Consumer USA Holdings Inc. Omnibus Incentive Plan. The restricted stock unit award includes a total of 4,995 shares, 60% of which vested at grant on February 27, 2015 and were settled in shares of common

(1) stock. The remaining 40% will vest in equal installments on each of February 27, 2016, February 27, 2017 and February 27, 2018. After the shares subject to the restricted stock units vest and are settled, they will remain subject to transfer and sale restrictions for a period of one year.
