With respect to the VMTP Shares owned by Wells Fargo Bank, National Association ('WFBNA'), on September 12, 2016, WFBNA assigned certain preferred class voting rights on the VMTP Shares to a voting trust (the 'Voting Trust') created pursuant to the Voting Trust Agreement, dated September 12, 2016 among WFBNA, Lord Securities Corporation, as voting trustee (the 'Voting Trustee') and Institutional Shareholder Services Inc. (the 'Voting Consultant'). Voting and consent rights on the VMTP Shares not assigned to the Voting Trust have been retained by WFBNA. The Voting Trust provides that with respect to voting or consent matters relating to the voting rights assigned to the Voting Trust, the Voting Consultant analyzes such voting or consent matters and makes a recommendation to the Voting Trustee on voting or consenting. The Voting Trustee is obligated to follow any such recommendations of the Voting Consultant when providing a vote or consent. WFBNA has the right to cause the Issuer to register the VMTP Shares pursuant to a Registration Rights Agreement, dated September 12, 2016 between the Issuer and WFBNA.
