On November 19, 2012, NextEra Energy Capital Holdings, Inc., a wholly-owned subsidiary of NextEra Energy, Inc. (NEE), sold \$500 million principal amount of its Series I Junior Subordinated Debentures due November 15, 2072 (Debentures). The Debentures will bear interest at 5.125% per year, payable quarterly. The Debentures are unconditionally and irrevocably guaranteed on a subordinated basis by NEE. The Debentures were registered under the Securities Act of 1933 pursuant to Registration Statement Nos. 333-183052, 333-183052-01 and 333-183052-02.
