#### Item 1.01. Entry into a Material Definitive Agreement.

On August 8, 2014, Flexsteel Industries, Inc. (the "Buyer") entered into an agreement with ELHC I, LLC (the "Seller"), to purchase certain real property from the Seller for \$24.1 million. The real property is located in Edgerton, Kansas and includes approximately 26.6 acres of land together with a building of approximately 500,000 square feet. The Buyer intends to utilize available cash and borrowing availability to fund the transaction.
