This Amendment No. 3 (<u>"Amendment No. 3"</u>) amends and supplements the statement on Schedule 13D filed with the Securities and Exchange Commission (the <u>"SEC"</u>) on January 6, 2017 (the <u>"Original Schedule 13D"</u>), Amendment No. 1 to the Original Schedule 13D, filed with the SEC on January 27, 2017 (<u>"Amendment No. 1"</u>), and Amendment No. 2 to the Original Schedule 13D, filed with the SEC on February 3, 2017 (<u>"Amendment No. 2"</u> and together with this Amendment No. 3, Amendment No. 1 and the Original Schedule 13D, the <u>"Schedule 13D"</u>) with respect to the shares of common stock, no par value (the <u>"Shares"</u>), of Clough Global Opportunities Fund (the <u>"Iss</u>uer"). Capitalized terms used herein and not otherwise defined in this Amendment No. 3 have the meanings set forth in the Original Schedule 13D, Amendment No. 1 and Amendment No. 2. This Amendment No. 3 amends Items 3, 4 and 5 as set forth below.

#### Item 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item 3 of the Schedule 13D is hereby amended and restated as follows:

Funds for the purchase of the Shares were derived from the subscription proceeds from investors in SCMF, SCMF II, SCLMF, SCS, SCEF 1 and SCEF 2 and the capital appreciation thereon and margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Since other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Shares reported herein. A total of \$26,566,352 was paid to acquire the Shares reported herein.

#### **Item 4. PURPOSE OF TRANSACTION**

Item 4 of the Schedule 13D is hereby amended and supplemented by the addition of the following:

The Reporting Persons have engaged, and may continue to engage, in discussions with management and the Board of Trustees of the Issuer regarding the long-term performance of the Issuer and

the trading of the Shares at a discount to

the Issuer's net asset value.

On February 10, 2017, SCMF, a fund of Saba Capital, submitted to the Issuer a notice of its intention to nominate three persons (collectively, the "Nominees") for election to the Issuer's Board of Trustees at the 2017 annual meeting of shareholders of the Issuer.
