On April 13, 2004, Sanofi-Synthelabo issued the following press release.

In connection with the proposed acquisition of Aventis, Sanofi-Synthélabo has filed with the United States Securities and Exchange Commission (SEC), a registration statement on Form F-4 (File no: 333-112314), which includes a final prospectus/offer to exchange and related exchange offer materials, to register the Sanofi-Synthélabo ordinary shares (including Sanofi-Synthélabo ordinary shares represented by Sanofi-Synthélabo ADSs) to be issued in exchange for Aventis ordinary shares held by holders located in the United States and for Aventis ADSs held by holders wherever located and has also filed with the SEC a Statement on Schedule TO. **Investors and holders of Aventis securities are strongly advised to read the registration statement and the final prospectus/offer to exchange, the related exchange offer materials and the Statement on Schedule TO, and any other relevant documents filed with the SEC, as well as any amendments and supplements to these documents, because they will contain important information.** Investors and holders of Aventis securities may obtain free copies of the registration statement, the final prospectus/offer to exchange and related exchange offer materials, and the Statement on Schedule TO, as well as other relevant documents filed with the SEC, at the SEC's web site at [www.sec.gov](http://www.sec.gov). **Sanofi-Synthelabo to sell to GlaxoSmithKline Arixtra<sup>®</sup>,  
Fraxiparine<sup>®</sup> and Notre Dame de Bondeville plant**

Deal conditional on completion of Sanofi-Synthelabo's offer for Aventis

Sanofi-Synthelabo announced today that they have signed an agreement with GlaxoSmithKline Group (GSK) regarding the divestment by Sanofi-Synthelabo, on a worldwide basis, of Arixtra<sup>®</sup>, Fraxiparine<sup>®</sup>, and related assets including the manufacturing facility located in Notre-Dame de Bondeville, France. As part of this transaction, GSK will assume responsibility for ongoing Arixtra<sup>®</sup> clinical trials.

As previously disclosed, Sanofi-Synthelabo began the sales process to divest its interests in Arixtra<sup>®</sup> and Fraxiparine<sup>®</sup> in connection with its public offer to acquire all the outstanding ordinary shares of Aventis announced on January, 26th 2004. The closing of this divestiture transaction is conditioned on Sanofi-Synthelabo successfully completing its offer for Aventis as well as on obtaining the requisite clearances from EU and US competition authorities .

Arixtra<sup>®</sup> (fondaparinux sodium) is a synthetic factor Xa inhibitor and Fraxiparine<sup>®</sup> (nadroparine calcium) is a Low Molecular Weight Heparin. World-wide sales of Arixtra<sup>®</sup> reached EUR 24 million in 2003. Sales of Fraxiparine<sup>®</sup> reached EUR 319 million in 2003.

The manufacturing facility located in Notre-Dame de Bondeville, France, is a state of the art plant in the field of injectable products. The facility employs 650 people.

The consideration for this transaction is EUR 453 million and will be satisfied by GSK in cash upon completion
